As a member of Amnesty International I believe that this and all other cases of human rights abuses must be investigated thoroughly and properly.

Amnesty International also believes that the amnesty law of 1978 is an obstacle to the thorough investigation of human rights violations in Chile during the rule of the military regime.

Proper investigation procedures into all cases of human rights abuse during that period would bring past cases into the open and prevent them happening again.

Your Excellency,

I am very concerned about the violation of anyone's human rights;

1992 is being marked as the 500th anniversary of the arrival on the continent. It therefore seems an appropriate time to highlight concerns with respect to unresolved human rights violations against indigenous peoples of the Americas, including the case of Nelson Vladimiro Curinir Lincoqueo.

I am very concerned about the extra-judicial execution of Nelson Vladimiro Curinir Lincoqueo in 1973 and am welcoming the investigations into his killing and I hope that the full truth will emerge and that those responsible for his death will be brought to justice.

Amnesty International believes this must happen with respect to this and all human rights violations committed in Chile in order to prevent such atrocities from recurring. I believe that the amnesty law of 1978 constitutes an obstacle to clarifying past abuses and preventing their recurrence and that the law should be repealed.
