Your Excellency :

I am writing out of concern for your government's amnesty act of 1978. Under this law, investigations of human rights abuses which occurred previous to 1978 have been closed and those responsible for the abuses have been given impunity.

I would like to bring specific attention to the case of Nelson Wladimir Cerinir Lincoguelo, a member of the Communist party who was abducted and murdered by government troops in 1973. His body was not recovered until 1990, and after his burial in 1991 a criminal complaint for homicide called "guerrilla" was presented to the courts. However, under the 1978 amnesty act the case of Nelson Wladimir

Curirir Lincogues is officially closed.

I ask that the amnesty act of 1978 be repealed and that an investigation be conducted into the death of Nelson Vladimiro Curirir Lincogues. Those found responsible should be brought to justice.
