Curriculum vitae Marten Oosting - National ombudsman the Netherlands

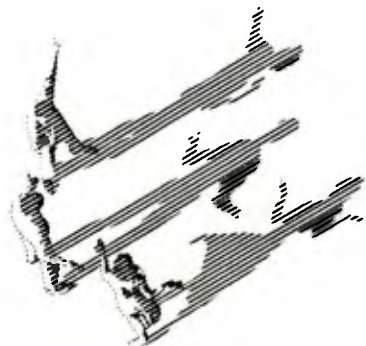
Marten Oosting, born in Winschoten - the Netherlands - on November 11, 1943 completed his study in Sociology (cum laude) in 1968 and graduated in Law in 1971, at the State University of Utrecht.

He worked as a senior lecturer at the Twente University of Technology in Enschede (Faculty of Public Administration) until 1978. He was full professor Administrative Law and Public Administration at the Faculty of Law of the Groningen State University until October 1, 1987.

On June 30, 1987 the Second Chamber of Parliament appointed him National ombudsman of the Netherlands, a post which he accepted on October 1, 1987.

Until his appointment as National ombudsman mr. Oosting was, among others, chairman of the Advisory Council for the Interior (a permanent statutory advisory body of the Government) and Chairman of the Evaluation Committee of the Act of General Provisions of Environmental Protection (an advisory body of the Minister for Housing, Regional Development and the Environment).

His publications deal primarily with the legal protection (of the citizens) against the Government, administrative organization and intergovernmental relations, and evaluation of legislation.
