New Delhi

Excellency,

I was looking forward to Your Excellency's visit to New Delhi for the revived Fourth G-15 Summit from 28-30 March but understand that it might not be possible for you to attend. My reason for writing is that I feel that we have to now consider the future of our Group, and your advice in this regard would be very valuable. In particular, the following aspects could be considered :

- (i) The future course of the Group in a fast-changing world.
- (ii) Frequency of Summits. While there has been some talk of the possibility of moving away from annual Summits, we have to bear in mind that on important areas of international concern, particularly in our attempts to establish a regular interaction with the G-7, it may be important to retain the annual nature of the meetings.
- (iii) To consider whether an agreed set period for the annual Summits make it easier for all of us to attend. The Dakar Summit had fixed the 2nd half of November for this purpose. We could consider whether this or some other period would be more convenient.
- (iv) The level and composition of the quorum.
- (v) The role of the Council of Foreign Ministers.
- (vi) A more focussed agenda dealing with specific issues of immediate concern particularly in the North-South context.

There can be other aspects as well, and I would greatly appreciate Your Excellency's advice. If it is at all possible, may I suggest that you might like to reconsider the possibility of attending the New Delhi Summit at what it is a crucial juncture in the history of functioning of our Group? Could I request Your Excellency's response by 22nd February so that we could consider further necessary arrangements?
