Dear Patricio,

We want to introduce our selves to you, that we are National Consumers Nigeria, from our foot note, you will know more about our Organisation activities.

From the information we gathered, we were made to understand about your plans to destroy approximately 15,000 to 23,000 Ha. of native forest and replace with euealyptus trees and other projects.

We therefore appeal to you not to allow the replacement of Native forest by encalyptus because of the following reasons:-

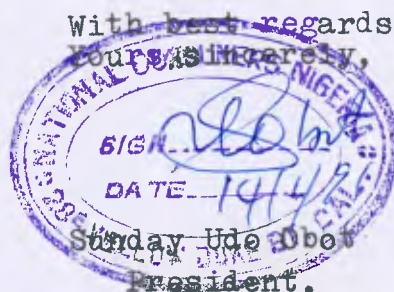
1. The forest which will be replaced by encalyptus belongs to a kind of forest that is one of the only neotropical forest left in the Southern hemisphere.
2. The forest that will be destroyed contains endemic speies that only accurs in Chile.
3. The area is well represented in your Protected Area National System.
4. This Native forest should be a subject of mamageent instead of being destroyed.
5. Lastly, if the substitution of native forest by encalyptus is allowed in this case, many other projects will be allowed destroying more than 200,000 ha, of evergreen forest.

Finally Sir, our Organisation's attention have been drawn to this effect, bear with us to serve the forest.
