Dear Mr.President,

Re a woman detained

As an Anglican priest and long standing member of the International peace movement Pax Christi I write to you urgently with regard serious human rights violations.

Belinda ZUBICUETA CARMONA, a political detainee, was imprisoned by the the military. She was arrested on 28 April 1986 by agents of the Central Nacional de Informaciones. Belinda ZUBICUETA CARMONA was locked up in a secret place, and tortured by the application of electric shocks to various parts of her body. She was then transferred to another place where she was forbidden to get up for two ^{days} and where she was threatened with execution with a gun loaded with blanks. In addition her torturers threatened to rape her and arrest her children. Throughout these days and in the face of constant harassment, she was forced to sign documents she was never able to read which were subsequently used against her.

For the last six years she has been deprived of her freedom without ever having been sentenced. Furthermore, during this time, legal proceedings were opened against her before a military court.

Mrs. ZUBICUETA CARMONA began a hunger strike on 20 May in protest at the negative response of the authorities following her request for temporary release and to demand that her sentence be passed as soon as possible.

In the light of all of this, Mr President, I plead with you to grant Mrs Belinda ZUBICUETA CARMONA a temporary release, to ensure her physical and psychological integrity and to provide her with the necessary medical treatment.

Too, I insist that her trial take place before an ordinary, competent tribunal as soon as possible and that she benefit from her full legal rights.
