Three stories, "Ezekiel's Gas & Roadworthy", or "Ezekiel's Gas and Roadworthy", are at sale, priced at four million and two hundred thousand dollars of the United States of America, for copying as three clothbound books.

No Canadian or American publisher, company, or other interest identified as Canadian or American shall be provided with any informations regarding any other products of the Author.

Delivery on a Springfield Armory M1A rifle, eight extra five capacity and eight extra ten capacity magazines, and cases of gas cartridges and ammunition would be appreciated regardless of the decisions on the three stories herein at sale.

Dollars of the Dominion of Canada, South African Krugerrands or pure South African gold are accepted. The amount of time necessary to complete the stories is not known. Scheduling may cause a delay in completion. The advance and royalties to be paid as quoted are recognized as tax free, or paid by the concern. Expenses must be accepted and paid for by the publisher, and/or company, et cetera.

A number of mechanisms from "Instructions for Manufacturers" with the minimum of the orders at four million dollars (American) as the advance are also at sale.

A series in small remote control attack helicopters, approximately eighteen inches in length, is available.

The computer enterprise as defined was cancelled, decreed no longer available as introduced, on Tuesday, November 3, 1992. Electronic equipment is available from "Instructions for Manufacturers"; no doubt any orders anticipated for the computer enterprise have gone to other computer companies.

On orders for printed books, and other prices

The terms of any free trade agreement are not applicable to any Agreement with the Author. No orders are sought from the People's Republic of China, the regions of the former Union of Soviet Socialist Republics, those who until only recently threw their lot in with the Communist Party Central Committee, the Republic of Germany, the Republic of Italy, and the Republic of Austria. Governments have always justified claims for percentages. Local government bureaucrats may well explain their claims for their amounts. The peoples of these nations are thoroughly without proof that they were not given many opportunities in the past.

No Canadian or American publisher, company, or other interest identified as Canadian or American shall be provided with any informations regarding any other products of the Author. The Author shall be the final judge.

Consortiums of companies may enter bids.

The Author is under no obligation to maintain the offering in any event after the deadline of one hundred and eighty days; in many cases a less lengthy deadline is specified, for example, ninety days. Scheduling may cause a delay in completion. The Advance and Royalties to be paid to the Author as quoted are recognized as tax free, or paid by the concern.

Expenses must be accepted and paid for by the publisher, and/or company, etc. The Author is the final judge.

The Author shall receive not less than twenty percent, 20%, of the, as above defined purchase price of the book, before any extra fee, to the readers. The Policy applies throughout Canada, only. At a limit of twenty percent the Author is, at least for now, reprovved.

No informations are to be submitted to an Canadian or American concern.

Such is the reproof that, therefore, contrary to the earlier establishment that that a commission of four hundred and fifty thousand American dollars be paid to the Author by any Canadian Publisher, or what is recognized as a Canadian company, or other Canadian interest before entering into negotiations or other informations gathering on outlines, sketches, manuscripts, etc. with a United States or other non-Canadian company, better prices have been seen by the Canadians in the past, the commission has increased, the commission is, what is that old clique undisclosed. No outlines, sketches, manuscripts, etc. are directly available from the Author to Canadian interests. The indirect availability carries such the now undisclosed commission, Canadian dollar fee, which is recognized as an advance if the Canadian interest forms an Agreement within five business days after the negotiation. The Author is the final judge in areas of disagreement. The negotiation must be limited in length and is between the non-Canadian and Canadian Editors, or other interests. If further negotiations are required the Canadian interest must guarantee with supporting documentation that reasonably if an Agreement is reached a minimum of the commission increased by a factor of three in, say, Canadian dollars in royalties on a singular book will be owing to the Author within four years from date of initial sales, as determined by the Author, on sales in Canada, to wave an addition commission

of amount of the first, Canadian dollar commission. Other service charges, expenses, and commissions may apply; submit the request. The Author again is the final judge. Again, this is to add to Loan and Credit Loss Reserves.

A note for twelve million and five hundred thousand Canadian dollars delivered to the Author from which a refund, or addition billing may occur would definitely be satisfactory. Corrections, clarifications, and modifications supplementing these directives may be requested.

On interests of the United States of America a note for eighty million American dollars delivered to the Author from which a refund, or addition billing may occur is now considered satisfactory on requirements as indicated as formerly applicable only on Canadian interests, et cetera.
