

The Urgent Action Network of Amnesty International has informed me of the reported status of three prisoners, Mauro Gonzalez Quispe, Rene Larico Aguilar, and Lisbert Fausto Mamani Morales. The three men are charged of the murder of two students at the beach of La Lisera. They are presently sentenced to the death penalty.

Amnesty International disagrees strongly, as do I, with the death penalty in any circumstance. The International Declaration of Human Rights specifically defines the death penalty as a violation of the right to life and the right not to be subjected to cruel or inhuman punishment.

This particular case has gone directly to President Patricio Aylwin, in whom is invested the power to commute death sentences. I urge that this punishment be waived and that the death penalty as a whole be abolished in Chile.
