Among the Committee's distinguished guests have been Presidents Richard Nixon, Ronald Reagan, and George Bush; the Presidents of the People's Republic of China and the Republic of Poland; the Prime Ministers of Canada, Finland, Hungary, and the Baltic Republics; the Ambassadors of Bahrain, Canada, Egypt, France, Hungary, Israel, Mexico, Mongolia, New Zealand, Poland, the former Soviet Union, and the United Kingdom; His Royal Highness Prince Hassan bin Talal of Jordan; The Right Honourable Margaret Thatcher; and His Excellency Mikhail S. Gorbachev.

Additional Committee activities have included the coordination of high-level trade and investment missions to the Middle East, China, Cuba, Poland, Hungary, and the former Soviet Union. The Committee coordinates briefings for its sponsors in Washington, D.C. with senior U.S. government officials as well as seminars and conferences on topics of current economic interest such as "Trade and Investment in Latin America" and "U.S. Trade with the Post War Gulf."

The Committee has hosted visiting official trade and investment missions and international visitor groups from Africa, the People's Republic of China, Hungary, Japan, South America, Mexico, the Middle East, Latin America, and the former Soviet Union.

The Committee is proud to work closely with the Governor of Illinois, the Mayor of Chicago, and leaders of the Illinois Congressional Delegation in its efforts.

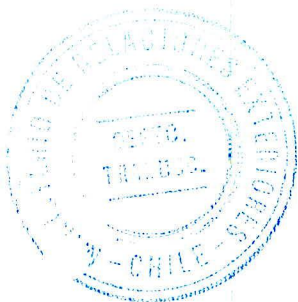

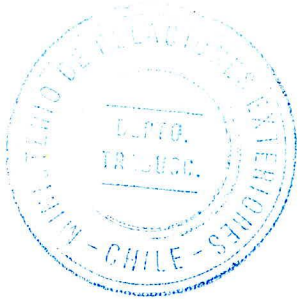
